SALE RULES:

1. Jr. Fair Members may enter the sale ring a maximum of three (3) times.
Limitations:
 - A. Maximum of 2 market steers/market heifers and 1 of any other species.
 - B. One (1) animal of each species, with a maximum total of 3 sales. (Example — 1 lamb, 1 steer, & 1 pig)
2. Exception to rule #1 — All animals being named Grand or Reserve Champion MUST be brought into the sale ring and auctioned in the Junior Fair livestock sale.
3. Sale Registration: Jr. Fair Exhibitors must register for the livestock sale at weigh-in of each particular species. Exhibitors of beef, sheep, swine and goat sale animals must complete a Jr. Fair Information Sheet. This sheet must be turned in at the end of each department weigh-in.
NO REGISTRATION — NO SALE
4. Options for non-sale ring market livestock:
 - A. Sell to Sr. Fair Board for support price.
 - B. For all freezer meat, each Exhibitor will need to complete a provided Wood County Agricultural Society Slaughter Verification form for each animal and return the form(s) to the Wood County Fair Office in order for the Exhibitor to receive his/her premium check. If an Exhibitor chooses to take a freezer meat animal through the sale ring, he/she will receive a check for premium only (not an additional market price per pound) for that animal.
5. All sale ring animals and those being consigned to the Fair Board will be loaded on trucks as trucks are available. Non-sale livestock will be released at 9 p.m. on Sunday including freezer meat.
EXCEPTION: Freezer meat hogs are release 9 p.m. Tuesday.

GENERAL RULES:

1. The Exhibitor is responsible for the care of his/her animal until it is released to the buyer.
2. All sale animals will be identified. All cattle, goats, sheep, and swine will have ear tags. Rabbits will be tattooed.
3. All recipients of the livestock sales will be charged 2% of their gross check for administrative fees.
4. Only animals shown and judged at the Fair are eligible to be sold. The committee reserves the right to cull animals of lesser quality to uphold the reputation of the sale.
5. The sale order will be determined and managed by the Livestock Sale committee.
6. All animals sold in the sale are to go to slaughter. All Grand Champions and Reserve Champions will be sold in the sale and will go to slaughter at a Fair Board designated slaughter facility. Exceptions are beef feeders, dairy feeders, rabbits, and poultry.
7. All animals consigned to sale must be sold at the auction and be bid off.
8. Each Exhibitor is responsible for selling his/her own project. If unable to be present at sale time, exhibitor must designate another Jr. Fair member to sell that animal. Only those animals represented by the exhibitor or other designated person will be sold.
9. Premium checks for all sale animals will NOT be distributed on sale day. They will be mailed by September 15, 2019.
10. All payments are due by Aug. 31, 2019. An interest charge will be charged on the balance due starting September 1, 2019. It will be at the rate of 2% per month, which is an annual rate of 24%.
11. All sale animals must be paid for before leaving the grounds. You must show paid invoice to dept. superintendent before loading any animal.
12. Pictures will be taken of all champion exhibits for publicity purpose; however, each newspaper reserves the right to decide which pictures are published.
13. To simplify the bidding process, all buyers will bid on an Exhibitor's premium indicated by a dollar amount, minimum starting bid of \$100.00. Example: \$25-\$50-\$100-\$200-\$300 per animal. The buyer will strictly be providing a premium to the Exhibitor and not buying actual animals.
14. There will be no solicitation of bids inside the sale barn after the start of the sale.

RABBIT SALE

1. Only pen of 3 meat rabbits and single fryers shown in the Wood County Fair may be sold in the annual sale.
2. Each Junior Fair Member will be allowed to sell one meat pen and 1 single fryer (count as 2 times through ring).
3. All rabbits sold in the Junior Fair Sale must weigh between 3 1/4 and 5.5 pounds each. Any single rabbit in the pen of three that does not weigh this amount will disqualify the whole pen from selling.
4. All rabbits which are sold will be tattooed.

POULTRY SALE

1. Only Pen of Three Meat Chickens may be sold in the Junior Fair Sale.
2. Each Junior Fair Member will be allowed to sell one pen of 3 meat chickens.

LARGE FOUL SALE

1. Each Junior Fair Member will be allowed to sell one (1) pen of 2 market ducks.
2. Each Junior Fair Member will be allowed to sell one (1) pen of 2 market geese.

TURKEY SALE

1. Each Junior Fair Member will be allowed to sell one (1) pen of 1 meat turkey.

MARKET GOATS

1. Market goats must be identified in April to be eligible for show and sale.
2. Market goats must weigh a minimum of 50 lbs. to sell. A base bid will be established on all market goats.

DAIRY PRODUCTS

1. Only Jr. Fair Dairy Exhibitors who are present at the sale (must sign in with Department Superintendent at sale ring) will share proceeds equally from the sale. Only 2 baskets of Dairy Products will be auctioned.

DAIRY GOAT PRODUCTS

1. Only Jr. Fair Dairy/Breeding Goat Exhibitors who are present at the sale (must sign in with Department Superintendent at sale ring) will share proceeds equally from the sale. Only 2 baskets of Dairy Goat Products will be auctioned. Exhibitors taking both Market Goat and Dairy/Breeding Goat projects must decide which project they want to go through the sale (either the Sunday Sale or Monday Sale) in order to comply with Sale Rule 1(B) listed above.

SHEEP

1. All sheep sold through the sale, and those consigned to the fair board, must go to slaughter.
2. The Ohio Sheep check off of 1/2% will be deducted from all members' checks.

SWINE

1. All Jr. Fair Market pigs entered in the sale will sell according to Swine Dept. Superintendent's direction. All pigs sold through the sale must go to slaughter.
2. The National Pork check off of \$0.45 for each \$100 value of hogs sold will be deducted from all members' checks.

MARKET STEERS/MARKET HEIFER/DAIRY STEERS

1. Buyers will bid on an Exhibitor's premium indicated by a dollar amount. The buyer will strictly be providing a premium to the Exhibitor. Exhibitor will receive premium plus base bid.
2. All beef sold through the Monday livestock sale must go to slaughter.
3. Beef sold in the Junior Fair Sale will have \$2.00 per head deducted and sent to the Ohio Beef Marketing Association for the promotion of beef.

BEEF FEEDERS (Steers & Heifer Calves)

1. All feeders will be sold to determine market price Saturday morning August 3, 2019 starting at 10:00 am in the Pavilion show arena. Sale ring bids on Monday will be premium only.
2. A check-off of \$2.00 per head will be deducted from the Exhibitor's checks.

DAIRY FEEDERS

1. All feeders will be sold to determine support price Saturday morning August 3, 2019 starting at 10:00 am in the Pavilion show arena. Sale ring bids on Monday will be premium only.
2. A check-off of \$2.00 per head will be deducted from Exhibitor's checks.
3. Up to \$10.00 will be deducted from sale proceeds to cover cost of vaccination shots given to feeders at May weigh-in.
